

Ministerial regulation issued by the Minister of Infrastructure and Water Management, of .....,

No. IENM/BSK-, laying down the destinations and periods of the day pursuant to the Decree traffic distribution between the airports Schiphol and Lelystad;

The Minister of Infrastructure and Water Management,

Having regard to article 2, paragraphs 1 and 2, and article 4 of the Decree traffic distribution between the airports Schiphol and Lelystad;

DECIDES:

#### **Article 1**

For the purpose of this regulation decree will mean: Decree traffic distribution between the airports Schiphol and Lelystad.

#### **Article 2**

Destinations which satisfy the following criteria will be designated as leisure destination:

- a. situated at a distance to Amsterdam Airport Schiphol of between 700 and 4000 kilometres;
- b. an average transfer percentage of less than 10%, measured over the five years preceding the designation;
- c. not a capital city;
- d. more than ten flights annually in the three years preceding the designation.

#### **Article 3**

The destinations which are reproduced in the schedule in the annex to this ministerial regulation, are designated as the leisure destinations referred to in article 2, paragraph 1, of the decree.

#### **Article 4**

Slots which have been released pursuant to article 2 of the decree can only be used for the following flights:

- a. flights to a destination situated at a distance to Amsterdam Airport Schiphol of more than 4000 kilometres; or
- b. flights from departure points or to destinations for which the airlines can prove that the share of transfer passengers, who transfer to or from a flight referred to under a, on board amounts on average to at least 10%.

## **Article 5**

The timeframes during which article 2 of the decree applies, will be set in the following order:

- a. 07:50 – 10:39 hours;
- b. 18:20 – 21:39 hours;
- c. 11:00 – 12:39 hours;
- d. 13:00 – 14:59 hours;
- e. 15:20 – 17:59 hours;
- f. 07:00 – 07:19 hours;
- g. remaining timeframes between 06:00 and 23:00 hours.

## **Article 6**

Article 2 of the decree applies during the following timeframes:

- a. 07:50 hours – 10:39 hours;
- b. 18:20 hours – 21:39 hours.

## **Article 7**

This regulation will enter into force as of 1 April 2019 in case the market approach of Schiphol Group has not produced the intended effect.

This ministerial regulation together with the explanatory memorandum shall be published in the Dutch Official Gazette (*Staatscourant*).
